4. FIRST AID MEASURES

Health hazard summary	Low toxicity - low irritant. Use safe work practices to avoid eye or skin contact and inhalation. Crystobalite is classified as carcinogenic to humans (IARC Group 1), however due to particle size (18 micron) and product use, adverse health effects are reduced as an inhalation hazard is not anticipated. Carbon black and titanium dioxide are classified as possibly carcinogenic to humans (IARC Group 2B).	
Eye	Low irritant. Contact may result in irritation, lacrimation and redness.	
Inhalation	Low irritant. Over exposure may result in irritation of the nose and throat, with coughing.	
Skin	Low irritant. Prolonged or repeated exposure to dust may result in irritation and dermatitis.
